**Viva-voce Exam for permission to practise before the**  
**High Court Division from 17-12-2016**

This is for information of all concerned that the Advocates who have qualified in the Written Examination for permission to practise in the High Court Division of the Supreme Court of Bangladesh held on 09-01-2016 have to appear before the *viva-voce* examination scheduled to be held from 17-12-2016. Detailed schedule of the exam will be announced in due course.

The former Judicial Officers who are entitled, under Rule 65A(ii) of the Bar Council Order and Rules, 1972, to be permitted to practise in the High Court Division may apply by 24-11-2016 in prescribed form for the ensuing *viva-voce* examination subject to payment of examination fee of taka 7,500/- (for Enrolment Sanad holders Tk. 6000/-) and Form fee of Tk. 500/- (Five Hundred) only by separate prescribed pay slip provided by the Bar Council and they will have to submit requisite papers (i.e. attested copies of academic certificates, Transcripts, Release order from service), four copies of attested passport size coloured photographs. The applications should reach the Secretary, Bangladesh Bar Council, Bar Council Bhaban, Dhaka-1000 on or before 24-11-2016. Their Admit Cards will be delivered to them from the Bar Council office during office hour (10:00 a.m. to 4:00 p.m.) on 6<sup>th</sup>, 7<sup>th</sup> & 8<sup>th</sup> December, 2016 and the time table of their *viva-voce* examinations will be published in due course. **Form fill up last date: 24-11-2016.**

Advocates qualified in the last written examination held on **09-08-2014** but could not succeed in the last *viva-voce* examination for permission to practise in the High Court Division and also as per Rule No. 65(A)(ii) meant for the former Judicial Officers may apply by 24-11-2016 in prescribed form for the ensuing *viva-voce* examination subject to payment of examination fee of taka 1,000/- (One thousand) and Form fee of Tk.300/- (Three hundred) only by separate prescribed pay slip provided by the Bar Council and they will have to submit two copies of attested passport size coloured photographs, a copy of Admit Card of the last exam. The applications should reach the Secretary, Bangladesh Bar Council, Bar Council Bhaban, Dhaka-1000 on or before 24-11-2016. Their Admit Cards will be delivered to them from the Bar Council office during office hour (10:00 a.m. to 4:00 p.m.) on 6<sup>th</sup>, 7<sup>th</sup> & 8<sup>th</sup> December, 2016 and the time table of their *viva-voce* examinations will be published in due course. **Form fill up last date: 24-11-2016.**
