Online Application Form for High Court Permission Written Exam.

Form fill-up of the written examination for permission to practise in the High Court Division will continue from 01-02-2024 to 01-03-2024 through online at <http://bar.teletalk.com.bd>

In continuation of the Bar Council Notice circulated vide memo no: BBC/Enrol/2024/1, Date: 01-01-2024, this is for information of all concerned that, the Advocates (having a valid Registration Number) who are entitled, under Article 21(1) and Rule 65A(i) of the Bar Council Order and Rules, 1972, to be permitted to practice in the High Court Division may apply online as a **Regular Candidate** through the provided link along with a total online payment of fee of Tk. 12,960/- (i.e. High Court Permission fee of Tk.10,000/- & Examination fee of Tk.2,000/-, Online Service Charge of Tk.960/-) through a Teletalk Prepaid Mobile Number.

Unsuccessful candidates of the previous written examination as well as of the last viva-voce examination whose written examination result stood cancelled as per the provision of Rule 65A(4) of the Bar Council Rules and also whose Registration Cards' validity remains unexpired on 01-03-2024, may also apply online as a **Re-appear Candidate** in the provided link. Such Application should have a total online payment of fee of Tk.2,160/- (i.e. Examination fee of Tk.2,000/-, Online Service Charge of Tk. 160/-) through a Teletalk Prepaid Mobile Number.

Unsuccessful candidates (of any of the previous High Court Permission Examinations) whose Registration Cards' validity gets expired on 01-03-2024 will require new Registration Number (to be obtained from Registration Department of Bar Council through applying Online) and those candidates shall have to apply in the provided link. Such Application should have a total payment of fee of Tk. 12,960/- (i.e. High Court Permission fee of Tk. 10,000/- & Examination fee of Tk.2,000/-, Online Service Charge of Tk.960/-) through a Teletalk Prepaid Mobile Number. This type of Candidates, who have got re-registration, are considered as **Regular Candidate, regardless of their Pupilage duration.**

NO APPLICATION CAN BE MADE WITHOUT A VALID REGISTRATION NUMBER. CANDIDATES WILL REQUIRE THE VALID REGISTRATION NUMBER TO START THEIR ONLINE FORM FILL-UP PROCESS. THEY WILL HAVE TO INSERT THE REGISTRATION NUMBER IN THE RESPECTIVE FIELD AS PER THE DISPLAYED INSTRUCTION, SELECT WHETHER HE/SHE IS A REGULAR OR A RE-APPEAR CANDIDATE AND GO ON THROUGH THE ONLINE FORM FILL UP PORTAL, STEP BY STEP.

THE NECESSARY PUPILAGE DURATION, REGISTRATION EXPIRATION DATE (5 YEARS' VALIDITY) AND LENGTH OF PRACTICE IN SUBORDINATE COURT TO THE HIGH COURT DIVISION REQUIRED FOR THE EXAMINATION WILL BE CALCULATED AS ON 01-03-2024.

Candidates will have to provide the required information step by step, upload a recent color Photo (of 300*300 pixel and the photograph should be in a formal manner) and the Signature (300*80 pixel) as per instruction. They will be able to have a look on the Preview of all the provided information before submitting the online application.

Candidates are advised to check/revise the Applicant Copy before paying the Exam Fee. If any error is found there, then they can submit a new/fresh application. **It is to be specially noted that, NO CORRECTION/ ALTERATION IN DATA/ NEW APPLICATION SUBMISSION IS POSSIBLE AFTER PAYING THE EXAM FEE. Candidates should make a Printout of the Applicant Copy and preserve it.**

N.B: After successful submission of online application, candidates must have to pay the required fee through a Teletalk Prepaid mobile number. **After submission of the application fee, the Online Application will be considered as submitted finally.**

PAYMENT METHOD

Candidates have to send 2 (two) SMS from a Teletalk Prepaid mobile. The SMS format is given below:

1st SMS:

BAR<space>USER ID and send to 16222

Reply: Applicants Name, Candidate's type and PIN

2nd SMS:

BAR<space>YES<space>PIN and send to 16222

Reply: Congratulations, Confirmation of payment with USER ID & PASSWORD

N.B: Please preserve the USER ID and PASSWORD carefully for future use. Payment Confirmation SMS, User ID, Password etc. will be delivered from a Specific Teletalk Number (16222 or 01550155555).

It is to be noted that in this Online form, candidates must give a virtual declaration about their *educational, practice in Bar and pupilage qualification* for the Exam. Every candidate who will pass in the written exam shall have to submit the **hard copies** of respective Registration Card, Certificate from the Senior, **Case List**, Practice Certificate from Bar with joining date thereto being clearly mentioned, yearly Bar Council payment document up to current year and other educational qualification certificates, mark sheets, equivalence certificates etc. as required by the Exam Rules. **No discrepancies among the provided information in online and in hard copy documents will be accepted. If any candidate provides any false/fake or incorrect/contradictory information either in online or in hard copy documents, his/her candidacy will immediately be cancelled at any stage of the examination along with entailment of further disciplinary actions.**



Written Examination date and Online Admit Card Collection Process will be notified in due course through Bar Council web notice.


